2. The organisers will hold delegates' names, email addresses, and institute names and may share them with the Dundee City Region Convention Bureau to keep you informed about the meeting's planning. This information will be shared with our secure, third-party event registration system, Convenus, to fulfil your registration.

3. Names, meal choices and dietary requirements will be given to any venue or catering organisations used for the meeting.
4. Names and appropriate accessibility requirements will be disclosed to transport providers, accommodation providers and conference and social venues where assistance may need to be arranged.
5. Dundee City Region Convention Bureau will administer a post-event evaluation survey on behalf of ENFSI OOS 2024 : Visualising the Future. No identifiable information will be required to complete the survey.
6. Your name, email address, and institute will be provided by request of law enforcement agencies bearing a warrant for the detection and prevention of crime.
